

District Awarded SALT Grant for Pearson Creek Watershed by Will Rhodes, 319 & Salt Project Manager

The Greene County SWCD recently was awarded a SALT (Special Area Land Treatment) Grant for the Pearson Creek Watershed. This will be the District's third SALT Grant in the last 10 years and the first district project in eastern Greene County.

The new Project is approximately 46,000 acres and runs South of Strafford, to Lake Springfield on the East side of Springfield. This area includes the James River, Turners Creek, Pearson Creek, Galloway Creek and Lake Springfield.

Sign-Up Now for Management-intensive Grazing Schools

Management-intensive Grazing System Schools will be held between April through October. There are no schools offered in the winter due to the need to hold some sessions outside. In Southwest Missouri there are usually seven to nine schools offered.

Rotational grazing management is grazing managed for both the benefit of the forage and the livestock. The emphasis is on Management. Livestock graze in each pasture long enough to harvest the forage, but moved to another paddock before too much leaf area is consumed. A basic system may have four or five pastures, while a more management intensive system will have eight to 10 pastures. Forage utilization by the livestock can usually be improved from about 30% on continuous grazing to 60% on a MiG system.

Management-intensive Grazing Schools were developed by the University of Missouri Extension Service and the USDA Natural Resources Conservation Service in the early-mid 1990's and have been offered around the state of Missouri every year since then.

School formats vary around the state. Some are a two-to-three day sessions and some offer a series of evenings with a Saturday field day. Part of the school is in the classroom and part out in the field on existing MiG systems. The schools all follow the same curriculum. Registration fees will vary from school to school. Meals are usually provided.

Topics Covered at Grazing Schools include inventorying farm resources, soils and topography, forage plant growth and species, pasture fertility, grazing basics, livestock water availability and distribution, fencing, forage quality, meeting the nutritional needs of livestock with pasture, economics of grazing, matching livestock with your forage resources, layout and design of a MiG system, extending the grazing system, farm visits covering forage estimates, grazing heights, and grazing system layout.

For more information on the 2009 schedule and/or to sign up for a session, contact the Greene County Soil & Water Conservation District at 831-5246, Ext.3. If you plan on attending, you need to get your name on the list as seating is limited and schools fill up fast.

Schools are conducted and sponsored by the USDA-Natural Resources Conservation Service, University of Missouri Extension and Area Soil and Water Conservation Districts.

District's 319 Grant Nearing Completion by Will Rhodes, 319 and Salt Project Manager

The district's Fellows/McDaniel-Fulbright Watershed (FMFW) Project is nearing completion.

Feb. 15, 2007, the Missouri Department of Natural Resources awarded an EPA section 319 Grant of \$269,946 to the Greene County Soil and Water Conservation District for the FMFW Project. This watershed lies north of Springfield and is made up of the South Dry Sac and the Little Sac River, including Fellows and McDaniel Lakes, and Fulbright Spring.

The main objective of the three-year project has been to reduce the nutrient load deposited into FMFW Watershed and ultimately remove it from the state's list of impaired and polluted waters.


The district has been offering cost-share funding to repair failing septic systems and pump-out neglected tanks, as well as educational material on proper septic maintenance.

In the last year the project has almost reached its goal.

The district has helped homeowners repair 15 failed septic systems and assisted in pumping 63 septic systems, more than twice the project goal of 25.

A third practice aimed at homeowners and nutrient reduction is the Lawn Nutrient Plan. The FMFW Project has been taking soil samples and developing nutrient plans on lawns in the area. These lawn nutrient plans tell homeowners exactly what kind of fertilizer blends and lime to buy, how much to apply, and when to apply. So far 48 of 50 plans have been completed.

Another objective of the project has been to reduce the sediment load deposited into the FMFW Watershed. To achieve this, the District has been offering cost-share for the installation of Best Management Practices (BMPs) such as Planned Grazing systems, Use Exclusion Fencing, Filter Strips and Riparian Buffers. To date the project has four Planned Grazing systems under construction and has completed half of our goal of 40 acres of Use Exclusion. The project is still looking for landowners that want to participate in the Filter Strip and Riparian Buffer practices. Both offer a one-time per-acre cash payment to participate as well as cost-share assistance for the installation. If interested call 831-5246, Ext. 3.

Like the two previous projects in the Little Sac River basin, this grant is funded by the one-tenth-of-one percent state sales tax for parks and soils through the Missouri Department of Natural Resources.

The Pearson Creek SALT Project is aimed specifically at improving water quality in the watershed. This is accomplished by offering cost-share opportunities with incentives to landowners to voluntarily incorporate farming practices that improve or prevent pollution. Some of the practices offered through this grant for the specified area include:

MDSP-2 - Allows an additional 80 acres over the regular DSP-2 cap.

Riparian Forrest Buffer - Requires a minimum 50 to 100 foot setback and tree planting. Will pay a one-time payment of \$1200/acre

Stream Protection - Minimum setback of 25 feet and NO tree planting. Allows flash grazing. Has a one-time payment of \$500/acre

Nutrient Management - Designed to encourage producers to apply fertilizer according to a nutrient-management plan. Will pay \$30 per acre per year to follow the plan and is limited to \$4500 per year per producer. Allowed to enroll in practice for three years.

Pest Management - Designed to minimize the use of agricultural chemicals by properly following a pest-management plan. Hayfields and pastures are eligible as is Alfalfa for weevil control. Will pay \$15 per acre per year for up to three years. Cannot exceed \$2500 per year.

Assessment Survey Underway for Cost-Share Funding by Eric Morris, District Technician

The Greene County Soil and Water Conservation District is currently working on a Needs Assessment for future cost-share allocation. This assessment covers the potential needs we have in Greene County for the next five years.

Landowners and operators can provide an opinion on district cost-share needs by filling out the survey. Surveys are available at the district office and will be available at the upcoming Southwest Missouri Forage Conference.

The needs include 11 concerns: sheet and rill erosion, gully erosion, grazing management, woodland erosion, irrigation management, sensitive areas, animal waste management, nutrient management, pest management, groundwater protection and stream-bank erosion.

In years passed, the Soil & Water Districts Commission would allocate a certain amount of cost share depending on what was used the year before.

Now, the commission is requiring districts to request funding for each practice ahead of time.

In July, 2009, cost-share allocations will be partly distributed based on the needs assessment developed by each district. The needs assessment will determine what resource concerns are a priority in each county by analyzing data from the surveys, past cost-share usage, MO County Profiles and informational meetings.

Your participation will contribute greatly to this important process.






